## **BY-LAW AMENDMENT**

17. Director's Term. The terms of each director's service shall extend until-the next annual meeting of the members for a period of two (2) years and subsequently until his successor is duly elected and gualified or until he is removed in the manner elsewhere provided. For the election of directors in the year 2003 only, the three candidates receiving the highest respective vote totals shall be elected for two year terms and the two candidates receiving the next highest respective vote totals shall be elected for one year terms. In the event the candidates for election in 2003 number five, the terms of office for each of the newly elected directors shall be determined by marking three slips of paper with the number "2", two slips of paper with the number "1" and having each retrieve one of the slips of paper by a blind draw. Those drawing slips of paper with the number "2" shall serve for two-year terms, and those drawing slips of paper with the number "1" shall serve for one-year terms. In the event the candidates for election in 2003 number less than five, the terms of office for each of the newly elected directors shall be determined as set out above with the twoyear terms of office being filled before the one-year terms of office. In all elections thereafter, all directors shall be elected for two year terms. In any election which results in a tie vote between two or more candidates, the winner shall be determined by the toss of a coin.
