EXHIBIT A

Article V(A) of the Articles of Incorporation:

Directors need not be members of the Association. All directors must be record owners of a unit or units within the Association, except as qualified below or as otherwise required to be eligible for membership by applicable law, during the term of their directorship and as a prerequisite to candidacy for a board position. An individual may be a director or a candidate for directorship under the following circumstances:

- i. The individual is an officer of the corporation owning a unit within the Association;
- ii. The individual is a trustee of a trust owning a unit within the Association;
- iii. The individual is a manager, managing member or sole owner of a limited liability company owning a unit in the Association;
- iv. The individual is a partner within a partnership owning a unit within the Association.

The Association shall have the right to require reasonable documentation from any director or director candidate evidencing compliance with the requirements of this section. Any individual who is not a record owner must provide such documentation at the time of submission to be a candidate for the Board of Directors and if such documentation is not.
